

1. Purpose of rental

The ski lift company Portes du Soleil Suisse SA (hereinafter referred to as PDS-ch SA) provides ski lockers for the temporary storage of ski and snowboard equipment, such as skis, snowboard, poles, boots, helmets, and other accessories.

2. Rental duration

Rental can be arranged for various durations: daily, weekly, or seasonal. The specific rental period is determined at the time of payment. Seasonal rental is approximately 4 months, from mid-December to mid-April, subject to change based on the ski lift operating dates.

3. Access and locker use

Depending on the type of locker, the renter receives either a code for locker access or 1 to 3 keys, requiring a deposit of CHF 15 per key. Additionally, renters of lockers located in Morgins, Champéry - Cable Car Station (Lockers No. 501 to 622), and Planachaux (Lockers No. 201 to 240) are provided with a code to access the room. Codes are sent via email or SMS and can also be obtained at our counters. Keys must not be duplicated, loss or theft should be immediately reported to PDS-ch SA. A replacement key may be issued at an additional cost.

4. Usage conditions

The lockers are intended exclusively for the storage of winter sports equipment. It is prohibited to store equipment exceeding the locker's capacity, as well as flammable, hazardous, illegal, or perishable items. Equipment must not be stored outside of lockers in the premises.

5. Inspection rights and removal of Items

PDS-ch SA reserves the right to inspect lockers if there is suspicion of illegal, hazardous, or non-compliant contents. At the end of the winter season, renters must empty their lockers entirely. Any equipment remaining in the lockers after the season ends will be regarded as abandoned and may be removed by the PDS-ch SA.

6. Renter's responsibilities

The renter is responsible for the correct use of the locker and the protection of stored equipment. Any damage caused to the locker through negligence or misuse will be charged to the renter.

7. Company responsibilities

The facilities in Champéry (Lockers No. 501 to 622) and Morgins are equipped with surveillance cameras. The company declines any responsibility for theft, loss, or damage to equipment stored in the lockers. Renters are encouraged to obtain personal insurance to cover their belongings.

8. Rates and payment

Rental rates are determined according to the rental duration and are displayed at the time of booking. Payment is due within the specified period. Delayed payments, especially for seasonal lockers, may lead to the cancellation of the reservation.

9. Termination and refund

In the event of early termination by the renter, no refund is provided. The company reserves the right to terminate the contract in cases of non-compliance with these terms or inappropriate behavior, without refund of paid amounts.

10. Changes to general conditions

The company reserves the right to adjust these terms and conditions. Any updates will be communicated to renters through a notice posted in the ski locker rooms.

11. Applicable law and jurisdiction

These terms and conditions are governed by Swiss law. Any dispute related to their interpretation or execution will be under the exclusive jurisdiction of the courts in the canton where the company is located.
